Square (1000 lake Sumter Landing, The Villages, FL, 32162 within Sumter County, Florida). I was notified by a female who was in the area of the stage, that another female (defendant) was very intoxicated and needed to stop drinking. The female pointed out the defendant who was standing in a crowd in front of the stage. I made contact with the defendant and asked her to step out of the crowd and speak to me. The defendant was visibly intoxicated and aggressive. The defendant touched me several times and I told her each time not to touch me. The defendant became increasingly argumentative and aggressive at which point she reached forward and pushed me with her right hand on my duty belt against my will.

At the time of the offense I was dressed in my agency-issued Sheriff's Office uniform bearing a Sheriff's Office badge on the left side of my chest, and jurisdictional patches on each sleeve. I was easily identifiable as a law enforcement officer.

A records check through the Sumter County Communications Center revealed the defendant has no criminal record.

Neither I nor the defendant sustained any injuries during the incident.

Due to the above-stated facts, I placed the defendant under arrest and transported her to the Sumter County Detention Center without further incident. The defendant was given a \$5,000.00 bond pursuant to the bond schedule.
