## SEVEN HANDGUNS, OVER 17 KILOGRAMS OF HEROIN/FENTANYL SEIZED IN NARCOTICS INVESTIGATION

Hudson County Prosecutor Esther Suarez has released the following information:

On Thursday, November 16, 2023, the Hudson County Prosecutor's Office Narcotics Task Force and the Hoboken Police Department arrested six individuals and executed multiple courtauthorized search warrants in Hoboken, Jersey City, Elizabeth and Montclair.

As part of the months-long investigation, seven handguns, two of which were reported stolen, over 17 kilograms of suspected heroin/fentanyl, over 2.5 kilograms of cocaine, and various illegal narcotics with a street value in excess of \$15 million were recovered. Additionally, over \$20,000 in suspected proceeds from narcotics transactions was seized.

Prosecutor Suarez credited the Hudson County Prosecutor's Office Narcotics Task Force and Hoboken Police Department with the investigation, with assistance from the Essex County Tactical Response Team, Union County SWAT, the Essex County Prosecutor's Office Crime Scene Unit, the Montclair Police Department, the Elizabeth Police Department, the Hudson County Sheriff's Office K9 Unit, and the Essex County K9 Unit in the arrests. The above charges are merely accusations and the defendants are presumed innocent until proven guilty. R.P.C.3.6(b)(6).
